In exercise of the powers conferred by section 31 of the Himachal 11/05/2022 Pradesh Municipal Corporation Act, 1994(Act No. 12 of 1994), the Governor, Himachal Pradesh, in consultation with the State Election Commission wherever requires, makes the following rules further to amend the Himachal Pradesh Municipal Corporation Election Rules, 2012 notified vide Notification No. UD-A(3)-7/2011, dated 23.03.2012 and published in Rajpatra, Himachal Pradesh on 24.03.2012, namely:-

> 1.Short title.- These rules may be called the Himachal Pradesh Municipal Corporation Election (Amendment) Rules, 2022.

In rule 16 of the Himachal Pradesh Municipal 2.Amendment of rule 16.-Corporation Election Rules, 2012(hereinafter referred to as the "said rules"),-

- in sub-rule(1)- (i) for the clause (f), the following shall be substituted ,namely:
 - is already registered as an elector in any other ward of the same Municipal Corporation or any other Municipal Corporation or any other municipality or Gram Sabha as the case may be, " or";
- after clause(f), the following clause shall be inserted, namely:-(ii)
 - "(g) is already registered as an elector in such part of electoral roll of a Legislative Assembly which is not a part of the concerned Municipal Corporation:

Provided that the person shall not be disqualified for

registration, in case he has already applied for deletion of his name in the electoral roll of such assembly constituency and submits an acknowledgment/ receipt in this regard.".

(b) for sub rule(2), the following shall be substituted , namely:-

"A person shall be entitled to be registered in the electoral rolls at one place only.".

3.Amendment in rule 26.- In rule 26 of the said rules, in sub-rule(3), for the proviso, the following shall be substituted, namely:-

"Provided that if a person is registered in the electoral roll of any other ward of the same Municipal Corporation or any other Municipal Corporation or any Municipality or Gram Sabha and has not applied for deletion of his name from such electoral roll, the Electoral Registration Officer shall not include such name in the electoralroll prepared under these rules:

Provided further that if a person is registered in the electoral roll of any Legislative Constituency of which the Municipal Corporation is not a part and has not applied for deletion of his name from such electoral roll, the Electoral Registration Officer shall not include such name in the electoral roll prepared under these rules.".
