4.	Filing of Appeals against the order of Deputy Commissioner before the Divisional Commissioner	Within ten days from the disposal of objections
5.	Disposal of Appeals by the Divisional Commissioner	Within ten days from the filing of Appeals
6.	Final orders of Delimitation of Wards by Deputy Commissioner Kangra	On or before 20th August, 2020
7.	Reservation of Wards for Members	Up to 30.07.2020

If no objection is received or no appeal is filed within stipulated period the Concerned Deputy Commissioner may issue final delimitation orders and start process for reservation and rotation of Wards. After finalisation of delimitation and reservation of Wards, order of this effect should

immediately be sent to the Government by the Deputy Commissioner as required under Sub-Rule 10 of the Rule 10, so that the Government may provide a copy of the final reservation order to the Commission in accordance with Rule 11 of the ibid Rules


