In exercise of powers conferred by section 31 of the Himachal Pradesh Municipal Corporation Act, 1994 (Act No. 12 of 1994), the Governor, Himachal Pradesh, in consultation with the State Election Commission, is pleased to make the following rules further to amend in the Himachal Pradesh Municipal Corporation (Election) Rules, 2012 notified vide this Department Notification No. UD-A(3)-7/201, dated 23.03.2012 and published in Rajpatra, Himachal Pradesh, on 24.03.2012, namely:-

- (1) These rules may be called the Himachal Pradesh Municipal Corporation (Election)

 (Amendment) Rules, 2023.
- (2) These rules shall come into force from the date of publication in Rajpatra (e-Gazette), Himachal Pradesh.

Amendment of rule 14.

In rule 14 of the 'said rules', for the proviso under sub-rule (1), the following provisos shall be substituted, namely:-

"Provided that nothing in this rule shall prevent the use of the relevant part of the current electoral rolls of the Assembly constituency for the preparation of draft rolls for the elections under these rules:

Provided further that the State Election Commission may use data base of the Election Commission of India for the preparation of the draft electoral rolls for the elections under these rules.".

Amendment of rule 16

In rule 16 of the 'said rules', for sub-rules (1) and (2), the following shall be substituted, namely:-

- "(1) A person shall be disqualified for registration in an electoral roll, if he, -
 - (a) is not a citizen of India; or
 - (b) is of unsound mind and stands so declared by a competent court; or
 - (c) is for the time being disqualified for voting under the laws relating to corrupt practices and other offences in connection with elections to municipalities or Assembly or Parliament; or
 - (d) is not ordinarily resident of the ward; or
 - (e) is less than 18 years of age on or before 1st January or the date as may be notified by the Commission for the preparation or revision of electoral rolls, as the case may be.
- (2) A person shall be entitled to be registered in the electoral rolls for only one ward of the Corporation.".

In rule 26 of the said rules, in sub-rule (3), for the proviso, the following shall be substituted, namely-

"Provided that if the applicant whose name is ordered to be included, is already registered in the electoral roll of any other ward or part thereof such name shall be deleted from that Electoral roll.".
